

RULES AMENDMENT OF GAME CONTEST – BS BATTERY

FREE GAME CONTEST ON SOCIAL NETWORKS WITH NO PURCHASING OBLIGATION

Article 1: Organization

BS BATTERY, a simplified joint stock company with a capital of €700,000, is registered to the Nanterre Trade and Companies registered under number 305 933 681. BS Battery's headquarter is located at 28 RUE EDOUARD NIEUPORT, 92150 SURESNES. BS BATTERY is organizing a free game contest on social networks called " SPECIAL GAME CONTEST | 2021 MotoGP WORLD CHAMPION " which will take place from Wednesday 3rd November 2021 at 5:20pm to Friday 26th November 2021 at 11:59pm (French time) via its official Instagram page. The present rules define the legal rules applicable to this game contest.

Article 2: Participation & Accessibility

The organizing company reserves the right to postpone, modify, cancel or renew the competition if circumstances so require. In any event, the organizing company shall not be held liable in this respect.

Any participation in the Competition by a minor is made under the full responsibility of the holders of parental authority over the persons concerned. Members of BS staff of the organizing company and their families, are excluded.


The simple fact of taking part in the competition implies the participant's unreserved acceptance of these rules. It is also specified that the 5 prizes to be won will be awarded to 5 different participants.
